Policy Title: Graduation Honours

Purpose

To clearly articulate the standards for graduating with additional honours so that standards are applied consistently and to make students aware of the requirements to achieve such recognition. Also, to identify the recognitions and honours that are recorded on students' transcripts and degree parchments as they may provide advantages to students when applying for scholarships, internships or employment after graduating from UCW.

Scope

This policy applies to all UCW students who completed degree requirements and are approved for graduation in their program of study during the period between Convocations.

Policy Statement

University Canada West recognises and honours graduating students who have a record of exceptional academic achievement over the duration of their studies.

1. Graduation with Distinction

- 1.1. UCW recognizes students whose academic performance is superior as evidenced by their final cumulative grade point average (CGPA).
 - 1.1.1.all graduating associate degree students who complete a minimum of 30 credits at UCW are automatically considered;
 - 1.1.2.all graduating bachelor degree students who complete a minimum of 60 credits at UCW are automatically considered;
 - 1.1.3.all graduating graduate students who complete a minimum of 30 credits at UCW are automatically considered.
- 1.2. Students shall receive the designation of graduating 'With Distinction' if they have achieved the following:
 - 1.2.1.Undergraduate students whose final CGPA on degree courses upon approval for graduation is a minimum of 3.67 shall be designated as graduating "With Distinction".
 - 1.2.2.Graduate students whose final CGPA on degree courses upon approval for graduation is a minimum of 3.80 shall be designated as graduating "With Distinction".
- 1.3. The notation "With Distinction" will appear on the degree parchment, the Convocation program, and the transcript for those students whose graduating CGPA meets or exceeds the threshold.
- 1.4. Since the designation "With Distinction" is conferred only when a student has achieved or surpassed a specified CGPA, failure to achieve graduation with distinction may not be appealed, although the grades on which the designation is based may be appealed through the grade appeal process.



2. Medal for Academic Excellence (formerly the Dean's Award for Outstanding Performance)

- 2.1. The student in each undergraduate and graduate program who has the highest cumulative Grade Point Average (usually a minimum of A-) on degree courses upon approval for graduation of all graduating students in the program is eligible to be considered for the Medal for Academic Excellence.
 - 2.1.1.All students graduating in each Convocation ceremony are eligible to be considered for the award;
 - 2.1.2. There will normally be one student from each degree program recognized at Convocation;
 - 2.1.3. Students with records of academic misconduct or misconduct may not be considered for the award:
 - 2.1.4.UCW reserves the right to make no award, or to make multiple awards, at any Convocation.

Definitions
