4. President's Communication

Bashir Makhoul expressed his gratitude to all who were involved in the communications process with DQAB. He proceeded to provide an update on several appointments, including the Board of Governors' representative in the Senate, VPA, and VP Student Experience. He mentioned that the results would be shared once finalized and arrangements were in place. In response to Michele Vincenti's question regarding recent updates from the federal government, Bashir Makhoul emphasized that the university is ensuring that its recruitment strategies and objectives align with the goal of attracting higher quality students. He noted that communication from the Minister's office indicated a directive not to exceed the current number of postgraduate students.

Bashir Makhoul also expressed appreciation for all the work that Maureen Mancuso, the outgoing Vice President Academic, has completed during her tenure at University Canada West. He also asked the members of the Senate to join him in expressing his gratitude for her tireless efforts and asked for this public recognition to be included in the official meeting minutes.

6. Question period

Penny Farley raised concerns about the changes by IRCC and the CAP on the number of students that the

university will be accepting, particularly the shift from undergraduate to graduate programs. In response, Bashir clarified that it's not a direct conversion of undergraduate numbers to graduate numbers. Instead, the government has indicated a desire to limit every institution in the country, within the province, on the number of undergraduate international students they can accept. Bashir further explained that by limiting the number of visas allocated to the university, it does not equate to shifting the allocation of seats from undergraduate to master's programs. Rather, the university is simply maintaining the existing number of seats for master's programs amidst the constraints imposed by the government.

7. Proposals from Standing Committees

a. Academic Planning and Priorities

i. Partnership Agreement:

Marina Candeia

a) Transfer Articulation Agreement with Selkirk College

Marina Candeia presented the transfer articulation agreement with Selkirk College, highlighting key details about the institution. Selkirk College has approximately 2,800 students enrolled in 80 different programs, with 75% of these students being domestic. The array of programs offered includes certificates, diplomas, as well as associate and bachelor's degrees. The agreement proposes the transfer credit articulation into UCW's Bachelor of Commerce (BCom) program from two of Selkirk College's programs. Furthermore, for admission into UCW's BCom and BABC programs, transfer credits will be evaluated on a case-by-case basis for students holding a Selkirk Associate of Arts degree. The rationale behind this agreement is to support undergraduate and domestic student enrollment while simultaneously strengthening UCW's collaborative relationship with public post-secondary institutions in BC. Followup questions regarding admission was answered by Marina Candeia.

b) Transfer Articulation Agreement with Awards for Training and Higher Education

M. Candeia presented the transfer articulation agreement with Awards for Training and Higher Education (ATHE), shedding light on key aspects of the institution. Established in 2011, ATHE has an extensive alumni network of around 40,000 individuals worldwide. The institution delivers programs and courses through over 280 ATHE-recognized centers in 55 countries. These programs encompass various levels of Certificates and Diplomas in fields such as Business & Management, Accounting, Law, Computing, and more.

The proposed transfer credit articulation focuses on ATHE's Level 5 Combined Extended Diploma in Business and Management, offering a pathway to UCW's BABC and BCom programs. Under this agreement, students can transfer up to 12 courses (equivalent to 36 credit hours) towards their degree at UCW. UCW faculty have thoroughly reviewed all course syllabi and program outlines provided by ATHE. Many of the courses offered by ATHE align closely with UCW's 200-, 300-, and 400-level courses. This level of alignment is not commonly found in many of our partnerships.

ii. Update: Calgary, AB Application

Adrian Mitescu

A. Mitescu provided an update on the Calgary, Alberta application and outlined the steps preceding its approval. The application process for opening a new campus in Alberta to offer a specific degree consists of two parts, named Part A and Part B. In Part A, the application is reviewed by ministry staff. This review assesses factors such as program duplication and program demand. If the decision is favorable in Part A, the application progresses to Part B. Here, it undergoes multiple reviews by the Campus Alberta Quality Council. It has been noted that the earliest feasible time for the campus to open would be Fall 2025 (unless the application for expedited review is approved)

b. Governance and Policies

Policy-related matters:

i. 5000 - Program Advisory Committee

Harpreet Ahluwalia

Harpreet Ahluwalia presented the rationale and proposed changes to the existing Policy 5000 – Program Advisory Committee. She emphasized the necessity for revisions, noting that the policy hadn't been updated for an extended period. She highlighted the inclusion of non-academic programs such as micro-credentials and the integration of input from academic affairs in the revisions. The scope of the policy has been clearly defined to apply exclusively to degree programs, explicitly excluding non-academic programs. Furthermore, she elaborated on the procedure and terms of reference, which now provide more detailed information regarding the inclusion of staff and faculty from other post-secondary institutions. She mentioned that extensive consultations were conducted with stakeholders to ensure comprehensive feedback. She concluded by sharing the implementation plan, which will be made public after receiving approval from the Senate meeting.
